### Working title of the project:

The prevention paradox - a comparison study of the validity of the prevention paradox in countries with different patterns of drinking and use of illicit drugs

**Abstract:** (Please describe objectives, methods and specify the research question(s), maximum 250 words.) The scientific literature on the prevention paradox is fairly limited in several respects; the number of empirical studies is rather small, the findings are not entirely consistent, there are significant methodological short-comings in several studies and the scientific debate is to some extent blurred by different use of concepts and operationalisations.

Most studies addressing the prevention paradox have been done on adults and have been fairly narrow or limited in terms of what kind of alcohol-related problems have been assessed. Only very few studies have addressed the validity of the prevention paradox among adolescents, although this group is often the focus for alcohol policy and prevention.

Young people are also often in focus for drug prevention activities and many of them are directed to the population as a whole. The number of students reporting drug related problems is much lower for drugs than for alcohol, but we will anyhow analyse the relevance of the prevention paradox for drug related problems

The goal is to study the validity of the prevention paradox separately for boys and girls and in countries with very different alcohol culture and drinking patterns. We will also address whether the prevention paradox is relevant for illicit drugs in countries with different kinds of use of these substances. More specifically the research questions include the following:

- 2. Are there gender differences?
- 3. To what extent are the findings the same or different for countries and drinking cultures?
- 4. Is the prevention paradox valid for drug use and different measures of drug related problems?
- 5. Are there gender differences?
- 6. To what extent are the findings the same or different for different countries and drug cultures?
