Trends in the use of cannabis and tobacco will be investigated for 15-16 year olds. Therefore, the trends for Flanders will be put within a European perspective, comparing the data from 2003 with the data from 2007. Several European countries will be picked to compare with Flanders. The data from the existing ESPAD - datasets will be processed using the necessary statistical methods. Possible relationships between items concerning the use of cannabis and tobacco and the items concerning psychosocial wellbeing will be investigated. The results could be useful for future prevention.
